BOARD OF HEALTH MEETING PUBLIC WORK SESSION MEETING MINUTES THURSDAY, DECEMBER 10, 2015

Carol Hertenstein, President of the Board of Health called the Board of Health meeting to order at 7:30 p.m. in the second floor west wing conference room.

Carol Hertenstein led the Pledge of Allegiance.

Reading of the Open Public Meetings Act Public Work Session statement:

Cindy Risseeuw, Secretary, read the Open Public Work Session statement: "This Regular Work Session Meeting of the Wyckoff Board of Health is now in session. In accordance with the Open Public Meetings Act, notice of this meeting appears on our Annual Schedule of meetings. A copy of said Annual Schedule has been posted on the Bulletin Board in Memorial Town Hall; a copy has been filed with the Municipal Clerk, The Record, The Ridgewood News and the North Jersey Herald and News – all newspapers having general circulation throughout the Township of Wyckoff. At least 48 hours prior to this meeting the Agenda thereof was similarly posted, filed and mailed to said newspapers. Formal action may be taken at this meeting."

Ms. Risseeuw stated, "This agenda also contemplates the Board of Health entering into a closed session discussion."

Approval of November 12, 2015 Public Business Meeting and Public Work Session Minutes:

Michael Sparozic motioned and Linda Brock seconded; Dr. Morski, Steve Clark and Lynne Spreen-Raffo abstained; remaining members present voted affirmatively.

Member of the public present:

None present.

Report of Board Members:

Steve Clarke suggested that information be made available to township residents regarding how and where to recycle CFL light bulbs. Brian Scanlan stated he will pass the information on the Environmental Commission.

Wendy Coffey, Municipal Alliance (MA) chairperson stated an anti-substance abuse program will be held in the spring at the high schools.

Ms. Coffey also stated the Mayor's Wellness Challenge is on hold for the winter.

Ms. Coffey stated the Stigma Free program's goal is to add membership from the community. The Stigma Free program plans to have float in the Memorial Day parade.

Report of the Board of Health President:

For the year 2016, Sgt. Brian Zivkovich will become OEM Coordinator and Lt. Charlie Van Dyk will assume the position of Deputy OEM Coordinator.

Ms. Hertenstein stated that the Mental Health First Aide program is available for free to township emergency responders. The two session program dates are as follow: January 25, 2016 (12 – 4 pm) and January 26, 2016 (8 am – 12 noon) at Christian Health Care Center.

Report of the Health Officer:

Ms. Angela Musella, Health Officer, reviewed the NWBRHC November 2015 Activity Report (distributed and attached) as follows:

- 1. Sixteen mandated establishment inspections were performed; all satisfactory.
- 2. Two animal bites were reported.
- 3. Four suspect Lyme disease cases were investigated.
- 4. One temporary event food license was issued (Wyckoff Reformed Church Holiday Fair).

Ms. Musella stated that a program will be available three evenings in March 2016 for all Bergen County Boards of Health discussing requirements for becoming a Healthy Town. NWBRHC will assist the township with the application to become a Healthy Town.

Ms. Musella stated that a representative from Ridgewood Water was not available in January 2016 to meet with the board; Ms. Musella will follow-up.

New and Unfinished Business:

The Board of Health nominating committee consisting of Michael Sparozic and Steve Clarke nominated Carol Hertenstein for President and Wendy Coffey for Vice President for 2016; there were no nominations from the floor.

An invitation was sent out to all board members for the Friday, January 1, 2016 Annual Re-Organization Meeting at Town Hall.

Public Hearing and Further Consideration of Ordinance #88:

Ms. Risseeuw, Board of Health Secretary presented Ordinance No. 88 for second reading for final passage, by title only, and a copy of this Ordinance has been posted on the bulletin board in Town Hall where public notices are customarily posted, and copies have been made available to members of the general public of the Township who have requested the same.

Ordinance No. 88 – An ordinance to delete Chapter 214 of the code of the Township of Wyckoff, "Sewage Disposal Systems, Individual" and replace Section 214 with a new chapter renamed, Chapter 214, "Standards, Procedures and Fees for Individual Subsurface Sewage Disposal Systems"

Closed Session:

All emails are subject to the Open Public Records Act and as such, may be requested by citizens. (This requirement is applicable to all members of the Wyckoff Planning Board, Zoning Board of Adjustment,

Library Board of Trustees, Recreation and Parks Commission, Board of Health, Environmental Commission, Shade Tree Commission, Design Review Advisory Committee and any other ad-hock committee regardless if it is sent from your personal/business computer or personal/business data phone.) There should be no expectation that the content of emails exchanged with municipal officials and employees will remain private."

Michael Sparozic motioned to close the Public session; seconded, Brian Scanlan; all members present voting affirmatively.
