Mayor Douglas J. Christie called the regular meeting of the Wyckoff Township Committee in the Municipal Court Room to order at 8:00 pm.

Flag Salute

The Township Committee proceeded with the Pledge of Allegiance led by Mayor Douglas J. Christie.

Invocation

The Invocation was given by Pastor Wesley Kenyon.

Open Public Meeting Act Statement

Municipal Clerk Santimauro read the "Open Public Meeting Act" Statement: "This regular meeting of the Township Committee of the Township of Wyckoff is now in session. In accordance with the provisions of Section 8 of the Open Public Meetings Act, I wish to advise that notice of this meeting has been posted in the lower level of the Memorial Town Hall and that a copy of the schedule of meetings has also been filed with the Township Clerk, and copies of this agenda and the annual notice of meetings, of which this is a part, have been heretofore sent to the Ridgewood News, The Record, and The North Jersey Herald and News all papers with general circulation throughout the Township of Wyckoff. At least 48 hours prior to this meeting the Agenda thereof was similarly posted, filed and mailed to said newspapers."

Meeting Open for Public Comment

The Township Committee voted unanimously to open the public portion of the meeting.

James Savage 448 Bromley Place- Mr. Savage asked if there was any update on the completion of the leases between the Township of Wyckoff and the YMCA and the Torpedoes for the construction of an artificial turf field on Pulis Field. It was mentioned that this is a public comment period not a question and answer period. Mayor Christie indicated that the Township and Mr. Landel are still working on the leases and that nothing has happened since the last meeting that Mr. Savage attended.

Mr. Swenson 190 Hillcrest Avenue- Mr. Swenson thanked and acknowledged the Township Committee for resolving the issue of the commuter parking fee and backing the increase down to a reasonable fee increase. Mr. Swenson complimented the Township Committee for their public service and indicated that both he and his wife commute at different times so he will be applying for two separate permits.

The Township Committee voted unanimously to close the public portion of the meeting.

Public Comment period to receive comments and suggestions for the 2014 Bergen County Open Space Park Improvement Grant Application. (The Township is considering an application to resurface the existing roller hockey rink surface in need of improvement)

Mayor Christie announced this is the public comment period to receive public comment and suggestions for the 2014 Grant Application which the Township will submit to the Bergen County Open Space Park Improvement Program.

Mayor Christie announced the Township is considering an application to reasphalt the existing Roller Hockey Rink surface which is located in the Memorial Field Athletic Complex behind Town Hall at 340 Franklin Avenue. Mayor Christie asked the Administrator to provide an update for members of the public.

Joyce Santimauro, Municipal Clerk certifies that a public notice of the advertisement was published in the Ridgewood News and public comments are welcomed and encouraged. The Township Administrator, Robert J. Shannon indicated that the Township of Wyckoff has an opportunity to apply for a Bergen County Open Space Park Improvement Grant. The Bergen County Open Space Program funds three different types of applications. The first application is a Land Acquisition. The second is Historic Preservation Application and the third is a Grant Program to achieve improvements to Municipal Parks and Recreation Areas. The Township's Finance Committee has been reviewing for the past three years the need to replace the surface field at the Roller Hockey Rink which is located in the Memorial Athletic Complex (which is municipally owned property). The surface was constructed approximately fourteen years ago and it has reached its useful life. Although it is not a safety hazard the rink surface needs to be re-asphalted. The Township has performed band-aid maintenance repairs but the surface is in need of a re-asphalting. This project has been proposed by Andy Wingfield, Recreation Director and the Scott Fisher, Department of Public Works Manager. The approximate cost would be \$41,550.00 the Township would apply for a \$20,775.00 grant and if successful the Township would fund a 100% match of \$20,775.00 to make the total of \$41,550.00. In order to stretch our grant dollar the DPW staff will be utilizes to dismantle the board system and then allow competitive sealed public bidding to bring in a contractor based on the lowest responsible and responsive bid price to mill the surface and re-asphalt the rink. The DPW will then reinstall the Roller Hockey board system. That is the recommendation of the staff. However, the purpose of today's public hearing is to invite the public who may wish to provide any additional public comments for the Township Committee consideration.

There were no comments from the members of the public.

Deputy Mayor Rooney, Finance Committee Chairman indicated that the Finance Committee has been aware that this outdoor recreation facility which is subject to the weather, would soon be reaching its useful life and this grant application provides an opportunity for a compliant grant application to fund half of the cost of the improvement, while Wyckoff tax dollars fund the other half through a 100% match.

Motion by Scanlan, second by Rooney to close the public comment.

#14-246 Resolution Urging Governor and Legislature to recognize and

Preserve the Strength of Local Pension Funding When
Considering the Recommendations of Governor Christie's
Pension and Health Benefit Sturdy Commission

WHEREAS, State actuaries confirm that the bipartisan pension and benefit reforms that were enacted in 2010 and 2011, coupled with the consistent pension payments made by responsible local governing bodies, are delivering the savings that had been promised by their advocates; and,

WHEREAS, when analyzing the fiscal health of public employee pension and benefit systems, the experts make a distinction between local commitments for local employees and retirees, and the commitments that are the State government's responsibility; and,

WHEREAS, according to the latest valuation reports, the local government Public Employees Retirement System (local PERS) and the local Police and Fire Retirement System (local PFRS) are actuarially sound, in large part due to the fact that municipalities and counties have made full employer contributions as required under the law for over a decade, with local PERS currently funded (comparing assets to liabilities) at 73.9% and local PFRS is currently funded at 76.9%, according to the experts; and

WHEREAS, the State PERS, on the other hand, is currently funded at 48.1%, and State PFRS is a little better, at 50.8%; and,

WHEREAS, the Officers of the League of Municipalities have submitted a statement to Governor Christie's Pension and Health Benefit Study Commission, urging that the Final Report and Recommendations of that Study Commission not, in any way, weaken the vitality of the local pension plans; and,

NOW THEREFORE BE IT RESOLVED, that the Township Committee of The Township of Wyckoff urges State policy-makers to recognize and protect the strength of the local PERS and local PFRS systems, and reject any recommendations that would threaten municipal budgets and property taxpayers.

NOW THEREFORE BE IT FURTHER RESOLVED, that, while we recognize the State's budget problems and we are anxious to help in any way we can, we cannot help in any way that shifts new burdens to our property taxpayers and our dedicated public servants.

NOW THEREFORE BE IT FURTHER RESOLVED, that certified copies of this Resolution be forwarded to Governor Chris Christie, State Treasurer Andrew Sidamon-Eristoff, our U.S. Senators Cory Booker and Robert Menendez, State Senator Kevin J. O'Toole and our two representatives in the General Assembly David Russo and Scott Rumana, and to the New Jersey League of Municipalities.

#14-248 Review of Best Practices Check List

WHEREAS, the State's Fiscal Year 2012 Appropriations Act or 2012 State Budget (P.L. 2011, c.85) requires the Division of Local Government Services to determine how much of each municipality's final 5% allocation of its CMPTRA and ETR aid (referred to as State aid) will be disbursed based upon the results of a Best Practices Inventory to be completed by each municipality by October 17, 2014; and,

WHEREAS, the Best Practices Checklist was completed and submitted to the State on October 16, 2014 and was discussed at the Township Committee's October 21, 2014 Public Business Meeting; and,

WHEREAS, the Township Administrator and the Chief Financial Officer have certified the results of the checklist.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Wyckoff, County of Bergen, State of New Jersey that they acknowledge the responses in the checklist, certified by the Township Administrator and the Chief Financial Officer, that were discussed and instruct the Municipal Clerk to certify and transmit to the Division of Local Government Services full completion of this requirement.

BE IT FURTHER RESOLVED that the public is advised that Consolidated Municipal Property Tax Relief Aid (CMPTRA) and Energy Tax Receipts (ETR) are not State aid, they are municipal taxes that were originally assessed and collected by the municipal government to fund municipal programs and services. The State took over their collection and never provided municipal governments with the full statutory distribution of ETR and CMTRA because the State retains for State use the revenue increases in those taxes. These State actions may help the State; however, they simply transfer the obligation to Wyckoff taxpayers to be funded through property taxes; and,

TOWNSHIP OF WYCKOFF ORDINANCE #1752

AN ORDINANCE TO AMEND SECTION 146-5 OF THE CODE OF THE TOWNSHIP OF WYCKOFF "PARKS, PLAYGROUNDS AND RECREATIONAL AREAS" TO CODIFY THE PROHIBITION OF USING PUBLIC PROPERTY FOR PERSONAL OR PRIVATE GAIN

BE IT ORDAINED by the Township Committee of the Township of Wyckoff, County of Bergen, State of New Jersey, that Section 146-5, "Misuse of properties; prohibited acts", is amended to add a new section, Titled, D as follows:

SECTION 1

Section 146-5

D. Public facilities shall not be used for commercial activities and/or personal monetary gain.

<u>SECTION 2</u> – Except as hereby amended, all other sections of Section 177-54 shall remain in full force and effect.

SECTION 3 – This Ordinance shall take effect upon final passage and publication according to law.

TOWNSHIP OF WYCKOFF ORDINANCE #1753

AN ORDINANCE TO VACATE A PORTION OF THE PUBLIC RIGHT OF WAY FRONTING 35 EDGEWOOD AVENUE, BLOCK 217/LOT 34

WHEREAS, it appears at one time a cul-de-sac was contemplated on Edgewood Avenue directly adjacent to Lot, 34, Block 217, as the public right of way extends into the front yard of Lot 34 by way of a curvature portion of the public right of way; and,

WHEREAS, the Township Committee wished to vacate such curvature portion so that the public right of way extends along Lot 34 in a straight line as depicted in the current Tax Map of the Township of Wyckoff; and,

THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Wyckoff, County of Bergen, State of New Jersey as follows:

SECTION 1. That a small curved portion of the public right of way adjacent to Block 217/Lot 34, on the Tax Assessment Map of the Township of Wyckoff, also known as 35 Edgewood Avenue, in the Township of Wyckoff, County of Bergen State of New Jersey, or as more particularly described in Schedule "A" attached hereto, being the same, is hereby vacated, and all public rights therein extinguished, subject however, to the reservations hereinafter set forth.

TOWNSHIP OF WYCKOFF TOWNSHIP COMMITTEE REGULAR BUSINESS MEETING SECOND FLOOR MUNICIPAL COURT ROOM TUESDAY, OCTOBER 21, 2014

SECTION 2. The Township of Wyckoff, for itself, its successors and assigns, reserves unto itself the right to construct, install, build, operate, maintain, use, repair, replace and relocate such public utilities, emergency services equipment and cable television facilities, within the described premises, which it may, at any time hereafter, deem necessary for the public health, safety, convenience and welfare. The Township of Wyckoff further reserves for the benefit of the Public Service Electric & Gas Company, Northwest Bergen County Utilities Authority, Ridgewood Water Company, Rockland Electric and/or successor utility companies, and any cable television company, the right to maintain, repair and replace utilities and facilities installed by them in, adjacent to, over or through the aforesaid land. All of the aforesaid rights shall be unaffected by this Ordinance.

SECTION 3. All ordinances or parts of ordinances inconsistent herewith are hereby repealed as to such inconsistency only.

SECTION 4. This Ordinance shall take effect after final passage and publication as provided by law.

- (2) The fee for a parking permit for a licensing year, for residents of the Township of Wyckoff shall be \$65.00 \$125.00 and for non-residents \$200.00 \$300.00.
