Meeting Called To Order

Mayor Douglas J. Christie called the regular meeting of the Wyckoff Township Committee in the Municipal Court Room to order at 8:00 pm.

Flag Salute

The Township Committee proceeded with the Pledge of Allegiance led by Mayor Douglas J. Christie.

Invocation

The Invocation was given by Pastor Wesley Kenyon.

Open Public Meeting Act Statement

Municipal Clerk Santimauro read the "Open Public Meeting Act" Statement: "This regular meeting of the Township Committee of the Township of Wyckoff is now in session. In accordance with the provisions of Section 8 of the Open Public Meetings Act, I wish to advise that notice of this meeting has been posted in the lower level of the Memorial Town Hall and that a copy of the schedule of meetings has also been filed with the Township Clerk, and copies of this agenda and the annual notice of meetings, of which this is a part, have been heretofore sent to the Ridgewood News, The Record, and The North Jersey Herald and News all papers with general circulation throughout the Township of Wyckoff. At least 48 hours prior to this meeting the Agenda thereof was similarly posted, filed and mailed to said newspapers."

Meeting Open for Public Comment

The Township Committee voted unanimously to open the public portion of the meeting.

Doug Swenson 190 Hillcrest Avenue. Mr. Swenson said he is a Wyckoff resident who uses the Wyckoff commuter park and ride facility at the Cornerstone Church. Mr. Swenson moved into town in 1985 and began using the commuter parking lot. He currently pays \$65.00 per year as does his wife for commuter parking permits for Cornerstone Church. He appreciates that the Township Committee does not utilize the commuter parking lot as a revenue producer and that fees are charged simply to cover costs for maintenance. Mr. Swenson said he is willing to pay any reasonable fee, however, he requested the Township Committee to reconsider the fee increases that were reported in last week's newspaper.

The Township Committee discussed their comments from the September 2, 2014 meeting regarding an increase in the Cornerstone commuter parking lot permit fees for the third consecutive governing body meeting. Cost figures were required to review the Township's obligation for both annual maintenance as well as expanding the gravel parking area into the adjacent Wyckoff Community Park parking area if an improvement were to go forward. Committeeman Rooney, Finance Committee Chairman, reviewed costs that he obtained from Scott Fisher, Public Works Manager, over the past four (4) years for snow plowing and salting the Cornerstone Church parking lot, which is part of the Township's agreement with the church to utilize a portion of their parking lot for commuter parking. The figures provided by Mr. Rooney did not include the additional cost to remove plowed snow from the Cornerstone Church parking lot due to the 72 inches that fell last winter in Wyckoff. The average maintenance cost for the past four (4) years is approximately \$13,000.00 per year.

It was explained that the commuter parking lot, the Town Hall for police car access, the three fire stations for fire truck deployment and the Ambulance Corp for ambulance deployment are priority assignments for Department of Public Works snow plowing during a snow storm. The paving cost to repave the commuter parking lot, which is part of the Township's obligation with the church, that is due in approximately three (3) to five (5) years is estimated at \$200,000.00 (viewed over 15 years would be approximate \$14,000.00 per year). The Township raises approximately \$30,000.00 a year in commuter parking fees. The estimate to resurface and provide security lighting in the parking lot for the gravel area in the Wyckoff Community Park is approximately \$210,000.00. The Township Committee reviewed these costs in the context of the program and indicated that the total available parking spaces at the church lot and the overflow parking area by the soccer field portion of the Wyckoff Community Park total 178 parking spots and the this year the Township sold 338 parking spaces and in the past has sold even more. The Township Committee discussed the policy and implication of selling more permits than spots available and the discussion resulted regarding the right number of parking permits to sell. It was also indicated that currently there is a waiting list of 65 individuals who have requested parking permits of which 58 are Wyckoff residents. A discussion resulted regarding church members who may be parking in the church spaces and utilizing the park and ride service.

Mr. Richard Koenigsberg, coordinator of the FLOW Rider Group which is a group of residents from Franklin Lakes, Oakland and Wyckoff who utilize the Cornerstone Church commuter parking, stated that the Cornerstone commuter parking lot is rarely ever full; and the reason is many folks who purchase permits do not use them every day due to business travel, vacation schedules and commuters who are not required to commute into the city to their office every day. Mr. Koenigsberg indicated the job growth in this post-depression time has been primarily in New York City, not out in the corporate parks of New Jersey. and this may be the reason why we have folks who have expressed an interest for a parking permit and who do not use the commuter parking lot every day. Mr. Koenigsberg said that the church employees are very good to the commuters and when it is cold they often open the lobby and give the commuters coffee. Police Chief Benjamin Fox was present, he described the efforts of the police officers to enforce parking with permits, the history of selling more permits than the number of parking spaces available and the concern of providing everyone with a parking space when selling more permits than spaces available.

The Township Committee's approach to a fee increase is not to establish a revenue producer, but to cover costs so that the tax payers who are not commuters do not shoulder that burden. A discussion resulted regarding the cost estimate to pave and light the gravel section of Wyckoff Community Park, the need is only to satisfy commuter parking, there is not a recreational program need to perform the improvement. Mr. Scanlan suggested selling 325 to 350 commuter parking permits on the condition that it is daily first come first service until the parking lot could be expanded, the permit would not be a guarantee for a parking space, and this would be an interim solution until after 2015 when the improvements are finished. Mr. Jepsen indicated that the problem appears to be capacity management and stated that oversubscription may not be the only way to approach this. He suggested additional data from monitoring the parking.

In summary the Township Committee decided to refer this issue back to the Finance Committee consisting of Committeeman Rooney and Committeeman Scanlan for another review based on this evenings discussion and to bring a report back to the full governing body for further discussion next week with a possible ordinance introduction on October 21, 2014 and adoption on November 3, 2014. Mr. Boonstra indicated that the current commuter parking fee equates to

a \$1.25 per week for a resident and \$4.80 per week for a non-resident. All agreed that this evenings' discussion was a positive dialogue.

#14-232 Support A-366/5-1713 Fair Taxing of Telecommunication Providers

WHEREAS, the Township of Wyckoff received a letter from Verizon, dated 9/3/2014 notifying the Township of Verizon's interpretation of State law that Verizon is exempt from payment of Business Personal Property Taxes of \$93,000 to the Township of Wyckoff; and.

WHEREAS, beginning in 2008, Verizon claimed itself tax exempt from the payment of Business Personal Property Taxes in five (5) municipalities, based on its own interpretation of the 1997 law, when it unilaterally determined that it no longer provided dial tone access to at least 51% of the local telephone exchanges; and,

WHEREAS, in 2012, the Tax Court issued a preliminary decision, supporting Verizon's self-serving interpretation of the law; and,

WHEREAS, both the Appellate Division and the State Supreme Court have denied the New Jersey League of Municipalities request to consider this issue, opting instead to await the Tax Court's final decision on the level of Verizon's current service. As the Tax Court proceedings drag on, with no end in sight, the taxpayers in over 100 municipalities including Wyckoff have been, effectively, denied the opportunity for relief; and,

WHEREAS, the New Jersey League of Municipalities and member municipalities including Wyckoff oppose the interpretation that Verizon can unilaterally determine whether it is subject to the tax in a given municipality; and,

WHEREAS, the statute specifically provides that those telecommunications carriers formerly subject to the New Jersey Franchise and Gross Receipts Tax Act would continue to be taxed, and that the law contains no provision for an annual "test" to determine whether the tax continues to apply.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Wyckoff, County of Bergen, State of New Jersey that it supports A-366/S-1713 as a legislative action to protect taxpayers and to provide clear direction to the court's regarding State Taxation of Telecommunication Providers.
