Mayor Douglas J. Christie called the special business meeting of the Wyckoff Township Committee to order in the Municipal Court Room to at 8:00 pm.

Flag Salute

The Township Committee proceeded with the Pledge of Allegiance led by Mayor Douglas J. Christie.

Invocation

48 Hour Special Open Public Meeting Act Statement

This special meeting of the Township Committee of the Township of Wyckoff is now in session. In accordance with Section 8 of the Open Public Meeting Act, I wish to advise that notice of this meeting has been posted in the lower level of Memorial Town Hall since March 5, 2014. A copy of the notice has been filed with the Township Clerk and copies were sent to the Ridgewood News, Bergen Record and the North Jersey Herald and News on March 5, 2014. All papers with general circulation throughout the Township of Wyckoff.

Meeting Open for Public Comment

The Township Committee voted unanimously to open the public portion of the meeting.

Mr. Doug Feick, 82 Heather Lane. Mr. Feick stated that he has owned the commercial building at 372 Franklin Avenue, also known as the Nolan Douglas building, for 37 years. Mr. Feick requested permission from the Township Committee to recoat his parking lot on Sunday, which is at variance with Chapter 104 of the Code of the Township of Wyckoff. The Township Committee discussed with Mr. Feick that other business property owners have requested similar relief and have been denied. Mr. Feick indicated that recoating a parking lot is different from repaving a parking lot. The Township Committee expressed a willingness to refer Mr. Feick's request to the public policy committee for review.

Mr. James Savage, 448D Bromley Place. Mr. Savage questioned why the township is introducing a budget this evening and a resolution establishing a temporary capital budget. The Administrator responded that the resolution for the temporary capital budget essentially allows the township to move forward and not be delayed for approximately half a month due to the process to authorize the capital improvements which have been determined by the Township Committee to be achieved once the budget is adopted. Mr. Savage next requested to be advised of the improvements contained within the resolution regarding general bonds and the capital improvement fund. Mr. Rooney responded that he will mention those projects during his budget statement tonight as finance chairman.

ORDINANCE #1733

AN ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK

WHEREAS, the Local Government Cap Law, N.J.S. 40A:4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to .5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and

WHEREAS, N.J.S.A. 40A:4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Township Committee of the Township of Wyckoff in the County of Bergen find it advisable and necessary to increase its CY 2014 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Township Committee hereby determines that a 3.0% increase in the budget for said year, amounting to \$394,028.00 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS, the Township Committee hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Township Committee of the Township of Wyckoff in the County of Bergen authorized membership of this governing body affirmatively concurring that, in the CY 2014 budget year, the final appropriations of the Township of Wyckoff shall, in accordance with this ordinance and N.J.S. A. 40A:4-45, be increased by 3.0% amounting to \$394,028.00 and that the CY 2014 municipal budget for the Township of Wyckoff be approved and adopted in accordance with the ordinance; and

BE IT FURTHER ORDAINED, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and.

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Direction within 5 days after such adoption.

Township Committee Comments Regarding 2014 Municipal Budget

Mayor Christie requested Finance Chairman Kevin Rooney and Deputy Finance Chairman Brian Scanlan to provide comments regarding the development of the 2014 budget before the Township Committee considers the Consent Agenda.

Mr. Rooney stated that prior to making his budgetary comments he wanted to mention one item which is not part of the budget. Mr. Rooney said that he was requested by Chief Fox to address with the Township Committee the damage to fences on Route 208 that have been damaged by New Jersey Department of Transportation (NJDOT) snow plowing operators. Mr. Rooney proposed that the Property Maintenance Officer consult with Police Chief Fox, and conduct a survey and a follow up should be performed by the Property Maintenance Officer regarding the damaged fences on residential rear yards abutting the Route 208 right of way (ROW) for the purpose of replacing or reusing the damaged fences. It was also agreed that the good side of the fence face out. The Township Committee agreed.

Regarding the municipal budget, Mr. Rooney extended his thanks to the Township Committee members, Department Managers, Administrator and Chief Financial Officer for their work on the budget. A Public Service Announcement (PSA) has been developed and distributed to the press today. The budget increase is less than 1%, which is lower than the county average and the increase in municipal taxes for the average home assessed at \$812,000.00 is \$54.46 per year. The Township experienced 12 snow events that required the Department of Public Works (DPW) to respond with ice control and snow plowing on the over 92 miles of roads in Wyckoff. The cost of those responses has been significant and the inclement weather has contributed to the need to spend more than we did last year on snow plowing and road repair. This budget funds \$1,300,000.00 in road repaving, but that amount will not cover all the roads that need repaving, it will cover roads most in need of repaving. The Department of Public Works (DPW) Manager indicates that if the township spent \$4,000,000.00 it would not cover all the roads that need to be repaved.

The budget includes \$200,000.00 for public safety improvements that includes police radios and police computers which will soon reach the end of their useful lives. The budget also includes funds for the replacement of an all season use 1997 DPW truck, replacement of windows at Town Hall with energy efficient windows, replacement of the 20 year old telephone system in Town Hall and Police Headquarters, Police and EMS communication improvements and computerized license plate readers to allow police to enforce safe driving at a higher level.

The capital budget also includes fire fighter safety gear, which is required by PEOSHA mandates, replacement of thermal imaging cameras for search and rescue and appropriations to sinking funds for the future replacement of fire pumpers.

Matching funds for an open space grant to replace ball field backstops are included as well as an appropriation into a sinking fund for major vehicle repairs, new doors at Fire Company #1, repairing steps into Town Hall that were in disrepair and a sinking fund for the future replacement of the Town Hall roof that dates back to 1953; improvements to the Larkin House and repair of the Town Hall heating system.

Deputy Finance Chairman Brian Scanlan commented on the 2014 budget. Mr. Scanlan thanked the department managers for working with the finance committee as well as Finance Chairman Kevin Rooney, Diana McLeod and Robert Shannon. Mr. Scanlan echoed the comments made by Mr. Rooney and indicated significant time and effort was devoted to this process. Mr. Scanlan said the budget is a good example of a compromise between competing goals, limited resources and investing in the township infrastructure. Mr. Scanlan pointed out that municipal taxes only represent 14% of a resident's property tax bill. This is a minimal increase this year; we are investing in the future and maintaining existing services at only \$54.00 for the average home. This year we experienced an awful winter that greatly impacted our roads. The repaying appropriation has been increased by 400% and the township will apply for grants for connector roads. This budget reflects our efforts which held over half of the appropriations flat at last year's amounts or less. The state continues to collect municipal taxes and not return the previous level of funding to the township since 2006.

Mr. Boonstra said that the budget is well prepared and presented and he extended thanks to all who worked hard on the development of the budget. Mr. Boonstra supports the budget.

Mayor Christie described the budget process as a "herculean task" and thanked all department managers, the finance committee for their efforts and, especially, Diana McLeod for her contributions.

#14-120 Support A-102/S-268 Requiring Direct Payment of Energy Taxes to Municipal Governments

WHEREAS, taxes on gas and electric utilities were originally collected by the host municipalities, and when the State made itself the collection agent for these taxes, it promised to dedicate the energy tax proceeds to municipal property tax relief; and.

WHEREAS, just as municipalities collect property taxes for the benefit of school districts, counties and other entities; the State is supposed to collect Energy Taxes for the benefit of municipal governments; and

WHEREAS, for years, though, State officials have diverted funding from Energy Taxes to plug holes in the State budget and to fund State programs; and

WHEREAS, the cumulative impact of years of underfunding has left many municipalities with serious needs and burdensome property taxes; and

WHEREAS, municipalities lost \$331 million in combined Energy Tax and Consolidated Municipal Property Tax Relief Aid (CMPTRA) funding in Fiscal Years 2009, 2010, and 2011, while also being denied scheduled incremental funding; and

WHEREAS, as a result of these cuts, in a number of municipalities property taxes are higher now, despite the fact that they are spending less, proving that the State's diversion of tax relief funding has contributed to higher municipal property taxes; and

WHEREAS, A-1021, sponsored by Assemblymen Daniel Benson and Wayne DeAngelo, and S-268, sponsored by Senator Linda Greenstein, would restore the \$331 million in municipal property tax relief funding, ensure that each municipality will be restored to the 2007 (SFY 2008) Energy Tax Receipts/CMPTRA level and adjust that amount to account for inflation.; and

WHEREAS, the bills would require certain energy tax receipts to be paid directly to municipalities and, thereby, would assure local property taxpayers compensation for hosting transmission facilities and lines that allow gas and electric energy corporations to serve customers and conduct business in our Garden State; and

WHEREAS, the time has come to restore to local budgets the millions in property tax relief that have been annually diverted to meet State needs.

NOW THEREFORE BE IT RESOLVED, that the Township Committee of the Township of Wyckoff, County of Bergen, State of New Jersey salutes the sponsors for listening to the Mayors in their districts and all around New Jersey and for advancing this legislation.

BE IT FURTHER RESOLVED, that we enthusiastically support and urge our State Legislators to pass A-1021/S-268.

#14-121 Authorize Shared Service with Wyckoff K-8 Board of Education for Vehicle Repair

WHEREAS, the Township Committee strives to use shared service agreements for the effective and efficient delivery of services where possible; and,

WHEREAS, the State of New Jersey encourages it's municipalities to enter into shared service agreements as per the State of New Jersey's "Best Practices" initiative; and,

WHEREAS, the Township of Wyckoff (provider) and the Wyckoff K-8 Board of Education (recipient) seek to participate in an Inter-local Services Agreement in order to save tax payer dollars and/or provide services more efficiently; and,

WHEREAS the Township Administrator and the Department of Public Works Manager recommend that the Township of Wyckoff enter into an Inter-local Services Agreement to provide vehicle repair service to the Wyckoff K-8 Board of Education; and,

NOW, THEREFORE, BE IT RESOLVED that the Township of Wyckoff hereby agrees to share, in accordance with NJSA 40:8A et seq (Inter-local Services Act), vehicle repair service provided by Wyckoff to the Wyckoff K-8 Board of Education.

NOW BE IT FURTHER RESOLVED that the Township agrees to provide this shared service as described in the Inter-local Service Agreement as follows but not limited to:

- This Agreement shall be effective commencing on April 1, 2014 and continuing through
 June 30, 2015. Either party has the right to cancel as per signed agreement by providing ninety (90) day written notification.
- Wyckoff shall provide to the Wyckoff K-8 Board of Education vehicle repair service on an as requested basis as per the agreement.
- 3. In consideration for this service the Wyckoff K-8 Board of Education shall pay the Township of Wyckoff \$50.00 per hour for all work performed by the Wyckoff Department of Public Works on the Wyckoff K-8 Board of Education vehicles listed in the agreement. Payments for future years shall be increased by 2% each year as provided for in the signed agreement.
- All other services as described in the Inter-local Service Agreement between the Township of Wyckoff and the Wyckoff K-8 Board of Education.

NOW BE IT FURTHER RESOLVED that the Mayor and the Municipal Clerk are hereby authorized to sign the Inter-local Service Agreement.

#14-122 Self Examination of 2014 Municipal Budget

WHEREAS, N.J.S.A. 40A:4-78b has authorized the Local Finance Board to adopt rules that permit municipalities in sound fiscal condition to assume the responsibility, normally granted to the Director of the Division of Local Government Services, of conducting the annual budget examination; and

WHEREAS, N.J.A.C. 5:30-7 was adopted by the Local Finance Board on February 11, 1997; and,

WHEREAS, pursuant to N.J.A.C. 5:30-7.2 through 7.5, the Township of Wyckoff has been declared eligible to participate in the program by the Division of Local Government Services, and the Chief Financial Officer has determined that the local government meets the necessary conditions to participate in the program for the 2014 budget year.

NOW THEREFORE BE IT RESOLVED by the Township Committee of the Township of Wyckoff, County of Bergen, State of New Jersey that in accordance with N.J.A.C. 5:30-7.6a & 7.6b and based upon the Chief Financial Officer's certification, the governing body has found the budget has met the following requirements:

- That with reference to the following items, the amounts have been calculated pursuant to law and appropriated as such in the budget:
 - a. Payment of interest and debt redemption charges
 - b. Deferred charges and statutory expenditures
 - c. Cash deficit of preceding year
 - d. Reserve for uncollected taxes
 - e. Other reserves and non-disbursement items
 - f. Any inclusions of amounts required for school purposes
- That the provisions relating to limitation on increases of appropriations
 pursuant to N.J.S.A. 40A:4-45.2 and appropriations for exceptions to
 limits on appropriations found at N.J.S.A. 40A:4-45.3 et seq., are fully met
 (complies with CAP law).
- That the budget is in such form, arrangement, and content as required by the Local Budget law and N.J.A.C. 5:30-4 and 5:30-5
- 4. That pursuant to the Local Budget Law:
 - All estimates of revenue are reasonable, accurate and correctly stated,
 - b. Items of appropriation are properly set forth
 - In itemization, form, arrangement and content, the budget will permit the exercise of the comptroller function within the municipality.
- The budget and associated amendments have been introduced and publicly advertised in accordance with the relevant provisions of the Local Budge Law, except that failure to meet the deadlines of N.J.S.A. 40A:4-5 shall not prevent such certification.
- 6. That all other applicable statutory requirements have been fulfilled.

BE IT FURTHER RESOLVED, that a copy of this resolution be forwarded to the Director of the Division of Local Government Services.

AN ORDINANCE TO AMEND CHAPTER 157 OF THE CODE OF THE TOWNSHIP OF WYCKOFF, SEWERS, BY REPLACING SECTION 157-62, SCHEDULE OF CHARGES, CHARGES FOR SEWER SERVICE, ESTABLISHING 2014 SEWER CHARGES FOR THE USE OF THE SANITARY SEWER SYSTEM OF THE TOWNSHIP OF WYCKOFF, BERGEN COUNTY, NEW JERSEY.

BE IT ORDAINED, by the Township Committee of the Township of Wyckoff, Bergen County, New Jersey, that an Ordinance entitled "An Ordinance Providing for and Establishing Sewer Service Charges for the Use of the Sanitary Sewer System of the Township of Wyckoff, Bergen County, New Jersey," (adopted April 1, 1970 as Ordinance No. 607), be amended as follows:

SECTION 1. Chapter 157, Sewers, Part 2, Article XI, Section 157-62, Schedule of Charges, is hereby replaced with the following:

- A. The sewer service charge hereby established for 2014 shall be sufficient to:
- (1) cover all the charges, costs and expenses related to the sewer service, such as, but not limited to, the charges of the Northwest Bergen County Utility Authority, the charges of the Boroughs of Midland Park and Waldwick, pump stations and ejector station operation and maintenance costs, and all the costs incurred by the Township of Wyckoff in collecting its sewer service charges; and,
 - (2) create a reasonable reserve for maintenance and repairs.
- B. The sewer service charge shall be an annual charge commencing upon the date upon which a building connection is approved by the Township, and such charge shall be on the following basis and this rate shall stay in effect until subsequently modified by ordinance amendment:
